Our 90 Day Return Policy

We accept returns on unused, unaltered products in original packaging with all accompanying manuals, instructions and accessories. If a product is defective, we will accept it with a detailed explanation of the defect, subject to validation upon receipt. Due to safety considerations, ammunition, guns, gun powder, primers, and troostands may not be returned. In addition, products requiring fuel or liquid may not be returned once fuel or liquid has been added. In some cases, products shipping directly from the supplier must be returned directly to the supplier. Without Proof of Purchase

Terms and Conditions

MidwayUSA offers some products that may be restricted by Federal, State and/or Local laws. We do not authorize the right to purchase any products that may be restricted in your area. You must be at least 21 years of age to purchase certain products such as airguns, ammunition, guns, black powder products, knives or reloading components. Under Federal law 18 U.S.C. 922(D)(1)-(9), persons with a legal disability are also restricted from purchasing certain products. When you purchase any of our products, you accept full responsibility to comply with all regulations that apply. You also warrant that you have read this information, are an adult and have no legal disability that would preclude you from purchasing restricted items. Please check your local laws before ordering. These commodities, technology or software should only be exported from the United States in accordance with the Bureau of Industry and Security Regulations (BIS). Sales Tax

MidwayUSA is not required to and does not collect sales or use tax outside Missouri. Your purchase may be subject to use tax in your state unless your purchase is exempt from taxation or your state does not impose sales and use tax. Your purchase is not exempt merely because it is made over the Internet, by catalog, or by other remote means. States that impose sales taxes require purchasers to report all purchases of tangible personal property or other taxable goods and services that are not taxed by the retailer and pay use tax on those purchases unless exempt under your state's law.
