All sales of firearms, ammunition and NFA items (suppressors and/or SBRs) are final. These items cannot be returned. Most merchandise purchased from Modern Warriors can be returned within 15 days of purchase/delivery for a full refund. If a firearm cannot be picked up from the transferring FFL dealer, this item may be returned subject to a 10% restocking fee. Under this scenario, the customer will be responsible for return freight charges. If the firearm has been transferred under a Form 4473, per ATF regulations, this firearm is now a used item regardless if it has been fired and therefore is no longer returnable. However, under a case-by-case basis, Modern Warriors may allow customers to return "Previously Owned - Unfired" firearms for a restocking fee of 25%. In the case of a suppressor or SBR, due to the required ATF approval process on these NFA items, there are NO refunds on any NFA items once the required Form 4 paperwork has been submitted to the ATF.
